USI FACILITY USE FEE CARD WILL INITIALLY INCLUDE SPOUSES.

YOUTH under 18 PRICES FOR SHOOTING WILL NOT REQUIRE A **USI FACILITY USE FEE CARD**

BY PAYING FOR **USI FACILITY USE FEE CARD** YOU WILL BE ABLE TO CONTINUE USING USI AT MEMBER RATES WITH DISCOUNTS FOR AMMUNITION AND SUPPLIES. AMMUNITION AND SUPPLIES PRICES FOR NON-MEMBERS ARE TYPICALLY MSRP. DISCOUNTS TO MEMBERS VARY DEPENDENT ON AVAILABILITY OF PRODUCTS.

IF AFFILIATED CLUB MEMBERS CHOOSE NOT TO PAY ANNUAL **USI FACILITY USE FEE** THEY ARE SUBJECT TO NON-MEMBER RATES WITH NO DISCOUNTS.

ACCESS CARDS WILL GO ON SALE MAY 4, 2022. ANNUAL FEE IS \$250 WHICH IS RENEWABLE ON YOUR INITIAL PAYMENT DATE. Once fee is paid you are in USI retail computer, cards will be printed and available after a few weeks.

THE USI BOARD HAS INITIATED A DISCOUNT OR FULL PAYMENT OPTION TO START THIS PROGRAM FOR THE FIRST 60 DAYS.
